Anderson questioned specific drawing change back to 24.

MCA New Business

1. HiMa Mix

a. Redfern questioned when MDT might be using this product in the future. Boysen shared how happy they were with the 19th Street project and how it turned out. Yerger discussed potentially using this product in areas where there is high traffic and not a lot of room for work. This product eliminates the need for a chip seal and helps bridge the gap between different products from a performance standpoint. Boysen stated the placement on the road was good, but the hand part was a bit harder. Fisher shared his experience and concerns with this new product and how there is a higher cost since it's thicker. Fisher also encouraged everyone to educate themselves on the differences with this product. Boysen stated that recipe came from Idaho. Gates will identify potential jobs in the future that this might be used on and send to MCA.

2. SBE/DBE Update from DOT

a. Wimmer discussed interim rule that went into effect Oct 4th. Anything related to DBE has been removed. Gates discussed how MT is doing it differently than the other states around. DBE language has been stripped from the contracts at this point. MDT has decided to maintain the contract requirements in the next letting. MDT will be releasing language about the DBE changes and continuing with the SBE program. Anything advertised after the date of the IFR (10.3) will just contain aspirational goals. Fisher questioned MDTs intent and if the DBEs already certified will automatically be SBE companies. Wimmer shared that all DBEs are already SBE companies as there is a higher threshold, so those quotes count towards SBE goals. Fisher questioned how the directory will be updated in AASHTOWARE but MDT knows that all DBEs are SBEs. MDT is planning to take a short pause on the SBE program and will put goals on projects in the future. Gates discussed MDT taking a step back and figuring out how to evolve the SBE program to work better for everyone. Fuglevand questioned if this was just a Montana process and what is driving this and why. Wimmer shared alignment of SBE program with a specific CFR. Rouse outlined that MDT plans to hold on SBE goals for now, but they intend to put these back in place to build up smaller businesses in Montana. Gates reminded group that this was an interim rule and everyone needs to be patient until this is implemented. Gaub shared concerns about goals and suggested that MDT ask contractors for input before putting these goals in place.

MDT New Business

1. Changes to the Q&A Forum

a. Salyards discussed timeline and the window that MDT has to accurately respond to questions from contractors. Amendments are growing and plan to move Q&A

closing date to Thursday at 5pm. Redfern shared impact to this change and questions typically come up due to plan errors. Smaller companies work on these items over the weekend and this change might eliminate the ability to identify issues as much as possible. MDT understands this issue but feels there is enough notice. Martini discussed prebid packets being posted months in advance.

2. Buy America/BABA Updates

a. Boysen discussed November letting and manufactured product waiver going away. Final fabrication needs to occur in the USA. Special provision has been updated based on guidance from FHWA. If categories are incorrect, contact MDT to work through.

- 1. VE Proposal: Gates discussed white paper provided. MDT encourages contractors' teams to work with your EPM when a potential VE comes up. Contractors shared concern that they decide to submit based on EPMs opinion. MDT encouraged all VE's to be submitted.
- 2. Bridge Summit: Rouse discussed increasing transparency on some items. Federal fiscal year info shared with the group. MDT will publish list of projects for the year along with schedule. Rouse discussed JS map that will include all the bridge work across the state to help contractors determine plan for upcoming work.
- 3. McMillan: Partnering Training has been posted on the website. Summit will be in March, same as week as construction summit. New partnering staff person in the process of being hired.
- 4. McMillan: Eticketing presentation in December.
